

## **Abstract Submission (Paper and Poster) - APPICON 2025**

APPICON is designed to provide a platform for researchers to share their recent scientific findings with the fellow scientists. The scientific program of APPICON 2025 will be modulated to provide ample opportunities to its member to present their scientific research in the form of Free paper or Poster presentation.

### **Who can submit:**

Members of APPI (Life Member/ Annual Member) / Non member wishing to participate in APPICON in-person mode can submit. The abstract can be submitted only after the registration is completed. The form of applying for membership is available at [Membership Benefits](#)

### **Free Paper and Poster Presentation:**

The allocation of abstract for Free Paper or Poster will be based on the research content, research domain and availability of slots in the sessions. All the submitted abstracts will be accommodated. The younger members of the APPI will be given preference of choices and efforts will be taken to provide equal opportunity to members from all parts of our country. The Free Papers presentation shall be done in 4 designated time slots (~90 minutes) spread over Day 1 and Day 2 of APPICON with two parallel sessions in each time slot. The Free Paper session will be structured to provide opportunity for 80-100 presentation by the members of the APPI. The Poster presentation sessions shall be held during two designated time slots on Day 1 and Day 2 of the APPICON. Please the structure of scientific programme of APPICON at Scientific Programs

### **Method of Submission:**

The abstracts will be submitted through an online portal only.

### **Guidelines for Submission:**

The abstract submission will be done in following steps

**Step 1 Verification of Registration ID.** You will be required to enter the registration ID and on confirmation from database your registration details will be shown.

**Step 2 Title of Abstract and Authors:** You will be required to submit the details of the all authors including their name (in Vancouver Format), Phone and email IDs. A copy of submitted abstract shall be sent to all authors for record keeping and consent after the submission of the abstract.

**Step 3 Abstract:** The abstract is to be structured as Introduction, Material, Results and Conclusion (IMRaC) and text pasted in appropriate boxes. The cumulative word limit of the abstract is 500 words.

**Step 4 Confirmation of order of Authorship and Presenting Author.** The order of the authorship and name of the presenting author can be changed at this step. The presenting author is by default the person submitting the abstract. The presenting author can be changed subject to registration for APPICON.

**Step 5 Annotation of the Abstract:** The annotation of the abstract will be used for grouping of abstract in various time slots depending upon the type of research. The submitting will be required to tick the appropriate annotation.

**Step 6 Preview of abstract and Submission:** A preview of the information provided shall be displayed for confirmation and submission. On submission, a copy of the abstract shall be sent to all authors for record keeping.
